Board and Management Changes

- Philip Hopkins (currently a Non-Executive Director) has been appointed Managing Director effective 30 June 2013.
- Shanker Madan will transition from Managing Director to Non-Executive Director on that date.
- William Johnson (currently a Non-Executive Director) will retire from the Board on 30 September 2013.
- > Farooq Khan will resign as General Manager, Finance and Corporate.

The Board would like to thank Shanker Madan for his work in the Company since its IPO in 2007 and in leading the DFS on Alara's flagship Khnaiguiyah Zinc-Copper Project in Saudi Arabia (completed as announced on 30 April 2013¹).
