77% Increase in Average Daily Concentrate Production

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 22nd shipment of copper concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Summary

- **22nd shipment of 3029.3 WMT copper-concentrate shipped on 24th August, comprising 520.4 MT copper and 3.2 Kg gold**
- **New filter presses deliver an average daily copper concentrate production (WMT) increase of 77% in August 2025**

The Al Wash-hi Majaza copper-concentrate plant has achieved production of 3029.3 WMT of copper-gold concentrate with approximately 520.4 MT of contained copper and approximately 3.2 kg of gold in its latest shipping cycle. This comprises the 22nd parcel of copper-concentrate exported from the plant, and departed Sohar Port on 24th August.

Performance Improvement & Production Boost

The interim filter presses procured from China were successfully commissioned earlier this month, and have been running without interruption since. Following the commissioning, the plant has seen a 77% increase in the average daily production of copper concentrate (WMT) during August 2025, as shown below:
