Alara JV Al Hadeetha Commences Hot Commissioning of Oman Copper Concentrator Plant

Alara Resources is pleased to report that hot commissioning activities for Al Hadeetha Resources' 1 MTPA¹ copper-concentrator plant, located at Al Wash-hi Majaza in Oman, have now commenced. Alara holds a 51% interest in the Oman JV Company.

Crushed waste rocks were introduced to SAG mill and load tests were completed at 60% of capacity. All plant and equipment is now functioning smoothly and the site team is focused on a safe, efficient and phased plant commissioning and ramp-up by introducing copper ore. The team expects to introduce copper ore into the hot commissioning process within 7-10 days.

Previously, in December 2023, a manufacturing error was observed in the SAG mill high speed (HS) couplings during dry commissioning. New sets of HS couplings were delivered on site and replaced successfully during January 2024.
